Phase 4 (FOUR) Requirements and Checklist

- 1- 1 ½ Hour Group Sessions (Process, Skill & MRT [16 week course])
- 1 Individual Treatment Session (per week)
- Thursday Court Sessions [1st, 3rd, & 5th (wkly if more than \$500 is owed) weeks]
- 3 hours AA/NA Meetings
- Minimum of 3 UDS's/when color is called –including Saturdays
- Alumni Meeting 3rd Tuesday
- Curfew 6 PM - 5AM [If unemployed or until employment has been verified]
- Curfew 10 PM – 5 AM [If employed (must provide proof of employment)]
- Proof of School Attendance, Work Attendance, Attendance at a Skill Building Workshop OR 6 VERIFIABLE Work Searches
- Phase 4 is a 6 month phase (not to exceed 7 months)
- Must be clean a minimum of 30 days to be considered to phase up
- Must have paid a minimum of \$2,750 toward program fees & 80% of restitution if applicable to phase up

If you miss a treatment, you are required to make the session up within a set period of time. If you miss court, a warrant will be signed for your arrest. Curfew is not an idea; it is a requirement that will be strictly enforced.
